# **Unit Goals**

This unit should enable students to:

# Term 1

- analyse social issues in French speaking countries
- respond to a variety of text types, giving information and/or opinions relating to a variety of social issues
- use argumentative/persuasive language

# Term 2

- analyse features of social issues in French speaking countries
- respond to a variety of text types relating to the world of work and technology demonstrating appreciation of content and register

# Content

The theme of "the world around us" will be addressed in this unit through topics such as:

Term 1: Social issues

- health and fitness
- environmental issues
- immigration

Verbs

gender issues.

Term 2: Work and technology

- different types of work
- vocational pathways
- technological and scientific innovations
- media issues.

# **Suggested Grammatical Content for Year 12**

• Revision of tenses taught thus far

- Introduction of plus-que-parfait
- Use of causative faire
- Present participle
- Future perfect
- Conditional perfect

# Pronouns

- Consolidation of personal pronouns
- Relative, demonstrative, interrogative and possessive pronouns

Suggested grammatical content for Year 11 in the ACT BSSS Continuing French course document includes revision/extension of present tense, regular & irregular, imperatives, verbs used reflexively, revision of future proche, revision/extension of passé composé, introduction of imparfait, si-clauses in present/future, après avoir structure, use of depuis with present tense, use of venir de with present tense, use of pour/pendant/il y a, negation, modal verbs with infinitive; revision/extension of question structures; revision/extension of use of direct and indirect pronouns. These will be reviewed as needed.

# **ACT BSSS Assessment Procedures**

**Completion of assessment items:** Students are required to substantially complete and submit all assessment items that contribute to the assessment for a unit unless due cause and adequate evidence is provided. Otherwise, any student who fails to submit assessment tasks worth in total 70% or more of the assessment for the unit will be deemed to have voided the unit.

**Late submission of work:** Late work will be subject to a penalty of 5% per day including weekends, unless prior arrangement is made for an extension, supported by evidence of due cause for the extension.

**Moderation, calculation of unit scores and course scores:** Moderation is conducted every semester to ensure comparability of grades from different schools. Your unit scores will be calculated from your results in the assessment items for each unit. These will be scaled through small group moderation with scaling group consisting of a comparable cohort for the course area in the ACT system. We calculate your course score in each T or H course from your best 80% unit scores. A course score indicates how well you performed in your course compared to all other students in the course's scaling group.
